(1) Each restricted stock unit represents a contingent right to receive one share of Resonant common stock.

(2) This transaction was effected pursuant to a Rule 10b5-1 trading plan previously adopted by the reporting person to satisfy the reporting person's tax withholding obligations upon the vesting of restricted stock units.

(3) This transaction was executed in multiple trades at prices ranging from \$3.2301 to \$3.24. The price reported above reflects the weighted average sale price. The reporting person hereby undertakes to provide upon request to the SEC staff, the issuer or a security holder of the issuer full information regarding the number of shares and prices at which the transaction was effected.
